RULES FOR DIRECTING SCIENTIFIC ARTICLES

General agreements

In the "Volgograd Scientific Medical Journal" in the form of articles, scientific works are accepted, reflecting the result of completed fundamental and practical scientific research, corresponding to the profile of the journal. The main headings of the scientific publication are: pharmacology, toxicology, morphology, experimental research, pathophysiology, clinical medicine, new methods in experiment and clinic, humanitarian problems of medicine. In addition to original articles, subject reviews are accepted for publication, as well as materials describing cases from practice, new treatment regimens, etc. in Russian and English.

Since 2019, the journal has been included in the List of leading peer-reviewed scientific journals and publications in which the main scientific results of the dissertation for the degree of Doctor and Candidate of Science (edition - January 2022) should be published in scientific specialties and their respective branches of science for which scientists are awarded degrees:

- 3.1.7. Dentistry (medical sciences),
- 3.1.9. Surgery (medical sciences),
- 3.1.18. Internal medicine (medical sciences),

Requirements for registration

The article is provided in 2 copies with an electronic version attached. The electronic version is provided to the e-mail address:

volgogradscientifmedjournal@gmail.com to the executive secretary or CD with the .doc extension. The maximum article size is up to 10 pages for original articles, up to 12 pages for thematic reviews, including tables and all illustrative materials. The editorial board reserves the right to shorten the article.

The article must be formatted in accordance with GOST R 7.0.7–2021, typed in the Microsoft World text editor, font - Times New Roman, 14 point size, 1.5 line spacing, paragraph indentation 1.27 cm, formatting in width, without hyphenation and page numbering, borders: 2.5 cm on all sides.

The title part of the article should contain the article type (Scientific article), index of the Universal Decimal Classification (UDC), article title, last name, first name, patronymic (if any) of the author(s), name of the organization and department in Russian and English.

Basic information about the author contains:

- name, patronymic, surname of the author (in full);

- the name of the organization (institution), its division where the author works or studies (without indicating the legal form of the legal entity: FGBUN, FGBOU VO, PAO, JSC, etc.);

 address of the organization (institution), its subdivision where the author works or studies (city and country);

- the author's email address (e-mail);

open identifier of the scientist (Open Researcher and Contributor ID –ORCID) (if available).

The address of the organization (institution) where the author works or studies can be indicated in full.

The e-mail address of the author is given without the word "e-mail", after the email address, do not put a dot.

ORCID is given in the form of an electronic address on the Internet. Do not put a dot at the end of ORCID.

The name of the organization (institution), its address, e-mail address and the ORCID of the author are separated from each other by commas.

Example - Sergey Yuryevich Glazyev

In the case when the author works (studies) in several organizations (institutions), information about each place of work (study) is indicated after the author's name on different lines and associated with the name using superscript numeric designations.

Example - Arpik Ashotovna Hasratyan¹, ²

If there are more than four authors, on the first page of the article it is allowed to give the names, patronymics in the form of initials and surnames of the authors. Names, patronymics in full form and surnames, as well as e-mail addresses, ORCID authors are placed in this case at the end of the article, along with additional information about the authors. At the same time, one of the authors is indicated on the front page of the article as the author responsible for the correspondence.

An example is M. K. Gulimov¹, Yu. I. Ammur¹, A. S. Seleznev², N. V. Davydova², V. V. Zverev¹, O. A. Svitich¹

When the email address of only one author is given, or that author is listed separately as a correspondent, the email addresses of other authors are given in the additional information about the authors at the end of the article.

Information about the author (authors) is repeated in English after the title of the article in English. The name and surname of the author (authors) are given in transliterated form in Latin in full, the patronymic is reduced to one letter (in some cases, due to the peculiarities of transliteration, to two letters).

An example is Sergey Yu. Glaz'ev

Additional information about the author(s) may include:

 – full names, patronymics and surnames, e-mail addresses and ORCID of the authors, if they are not indicated on the front page of the article;

- academic titles;

- academic degrees;

- International Author Identification Numbers other than ORCID.

Additional information about the author(s) is given with the words "Information about the author (authors)" preceding the words "Information about the author (authors)" and indicated at the end of the article after the "List of sources".

Example – Author information

Yu. A. Zubok – doctor of sociological sciences, professor;

V. I. Chyprov – Doctor of Sociological Sciences, Professor.

Information about the authors

Ju. A. Zubok – Doctor of Science (Sociology), Professor;

V. I. Chuprov – Doctor of Science (Sociology), Professor.

The main text of the article can be structured and consist of the following parts:

introduction;

 the text of the article (with the highlighting of the sections "Materials and Methods", "Results", "Discussion", etc.);

- conclusion.

It is allowed to divide the main text of the article into thematic headings and subheadings.

Captions and captions to the illustrative material are given in the language of the text of the article and, as a rule, are repeated in English.

The main text of an article in a publication can only be in one language. Mixing text in two languages in one article is not allowed.

Tables are placed in the text in the course of presentation. Illustrative material with a total maximum area of up to 750 sq.cm. and tiff extension, must be prepared for black and white printing. Appropriately numbered figure captions are printed at the end of the article after the bibliography. In captions to microphotographs, it is mandatory to indicate the methods of staining and magnification.

Requirements for the order of presentation of the material: a brief update (without a title), the purpose of the work, research methodology, research results (with discussion if necessary), conclusion, literature, a brief abstract of the article (abstract) with key words (Key words) in Russian and English.

Cited literature is given after the conclusion of the article in alphabetical order (Russian, then foreign sources). In the text of the article, literary sources are given in the form of numbers enclosed in square brackets, according to the list of references presented. The maximum volume of the list of used literature should not exceed 15 sources. References to publications earlier than 2015 should be exceptions (priorities, main methods, generally accepted standards and classifications). Links to unpublished articles, abstracts and preprints are not allowed.

Bibliographic entries in the list of off-text bibliographic references are numbered and placed in the order of citation of sources in the text of the article.

Additionally, a list of off-text bibliographic references in Latin ("References") is given according to the chosen style of the design of the list of off-text bibliographic references adopted in foreign publications: Harvard, Vancouver,

Chicago, ACS (American Chemical Society), AMS (American Mathematical Society), APA (American Psychological Association), etc. The numbering of entries in the additional list of off-text bibliographic references should match the numbering of entries in the main list of off-text bibliographic references.

The bibliographic record for the article bibliographic list is made according to GOST 7.80, GOST R 7.0.100.

Guided work should be accompanied by:

- a letter from the title organization and a letter to the head of the department;
- a completed (possibly by hand) and signed by two reviewers a review direction (the form is presented on the website).

Preparation for publication and publishing rights

As materials arrive, a portfolio of publications is formed. The final decision on publication is made at a meeting of the editorial board, taking into account the opinion of the reviewer appointed by the editor-in-chief or his deputy within 3 months from the date of receipt of the article. The date of receipt is the day of receipt by the editors of the final text. Rejected articles are not reviewed or returned.

Authors' signatures under the article mean the automatic consent of the authors to be published in the main issue or annex on editorial terms, a guarantee by the authors of the rights to the originality of the information contained in the article, compliance with international and Russian legal norms in experimental, preclinical and clinical studies, as well as consent to the transfer of rights to publish and translate this article to the Volgograd State Medical University Publishing House.

Publication in the "Volgograd Scientific Medical Journal" is free of charge, the authors of the article only pay for the cost of the journal issue sent for nonresident authors by mail, according to the addressees provided. The form of payment is non-cash. The payment form is provided on the website and on the last page of each issue of the Journal.
